# Excellence Award for Social and Environmental Responsibility

This award is open to IHF Members, their member hospitals, and health service providers who demonstrate excellence or outstanding achievements in advancing social and environmental responsibility. The nominated programme will be implemented at organizational level (i.e. not in isolation in a unit or department). The programme will clearly demonstrate measurable impact in the three key areas of organizational sustainability strategy and delivery.

- Leadership and governance: efforts to ensure structures and practices are in place to promote leadership accountability and reporting, sustain the programme, engage and empower employees to act on responsibility issues, and act collaboratively across communities and with relevant stakeholders.
- Health, equity, and wellbeing: efforts to assess the vulnerabilities in communities to better target services, increase access to universal health coverage, deliver health and prevention services in an equity-based way that support mental and physical wellbeing, prevent ill health, and positively influence environmental and social determinants of health.
- Environmental impact: efforts to reduce the environmental footprint of an organization and ecosystem, build resilience to climate change impacts, and to transition to low-carbon care through operational services and clinical practice.

The recipient of this award will demonstrate an innovative programme with measurable impact in the three key areas of organizational sustainability strategy and delivery.

Submissions could aim to remedy deficiencies in existing products, processes, and services, or create entirely new categories of goods and services, positively disrupting ways of thinking and operating. It should be possible for each innovation to be scaled to other settings, regions, or countries.

## Submission guidelines for the Innovation Hub and IHF Awards

- Entries must be submitted through the IHF online submission platform.
- All entries must be in English, and abbreviations and acronyms must be defined.
- Submitters must choose if they wish to enter the IHF Awards or the Innovation Hub.
- Each programme has a dedicated online entry form which requires submitters to provide information about the organization.
- It is possible to submit an entry to both the Innovation Hub and IHF Awards. If you choose to do so, please indicate this in your application and use the same contact information in both applications.
- Submitters can upload up to 5 relevant documents in PDF and Word file format. Maximum upload file size is 32MB.
- Links to videos may also be submitted as supporting information.

**The deadline to submit applications for both the Innovation Hub and the IHF Awards is extended to 3 May.**

3. Outline the specific goals and targets envisaged prior to initiation of the project, programme, or service. Are these goals and targets specific, measurable, attainable, relevant and time-bound in addressing the identified issues and challenges? 300 words

4. Describe the steps and stages involved in implementing the project, programme, or service. Include in the description the involvement of management, staff, patients, and other stakeholders. If needed in the implementation, how would additional resources be secured? 300 words

5. How does this project, programme, or service demonstrate the organization's excellence or outstanding achievement in promoting social and environmental responsibility? What have been the significant results, outcomes or improvements and how have they been measured to prove that this project, programme, or service is beneficial, efficacious, and/or cost-effective, etc.? 300 words

6. Describe how the project, programme, or service was received by the organization's stakeholders (management, admin and clinical staff, and patients). Has the project been recognized by the community or received an award nationally, regionally or internationally? Has the new project been adopted by other organizations and what is the likelihood for broader use? 300 words
